



How to work well with team members?

Top principles to implement BY CAROL BROOKS, SR/WA

magine a team member starts an argument with you.

Your first reaction is to become angry, but you choose the higher ground. You stay positive even though your heart is hurt and disappointed. The reality of human relationships is that conflict erupts, and this is primarily caused by differing points of view. A difficult task presents itself because as long as there are more than two human beings trying to collaborate together, we must continue to find ways to work well with all kinds of people, their personalities and (honestly) their weirdness. Conversely, the good thing is that conflict gives us the rite of passage to work together and enjoy a stronger relationship for overcoming the struggle.



TRUE NORTH PRINCIPAL

In order to work well with all team members, we should focus on principles that form our beliefs, values and convictions. I call these True North principles.

True North principles are the natural laws of human conscience. These laws are timeless. Holding fast to our True North principles and living according to them—even when life gets crazy—is the surest way to find your personal center of balance.

Let's look at some of the principles

that will hold us steady over the long haul and how we can implement them in our lives to become a better team player:





INTEGRITY

We've all been there: standing at a fork in the road, facing a choice between right and wrong. It may be a critical moment in our lives when we're encountering a life-changing decision. The right path may be the rockier road—narrow and steep, riddled with potholes. Yet anxious to make a choice, we quickly glance to the wrong way. The wrong road looks easy, but something deep within us struggles for higher ground. That's integrity at work. It helps us be true to ourselves, even when we have to choose the toughest path. Our team deserves the very best of us. Don't compromise your values. Stand on the solid ground of who you really are. If excuses begin to fill your mind and you rationalize why a compromising choice makes sense, take a step back and put the excuses in the trash. Instead, look at your choices from the clear lens of a good conscience.

FAIRNESS

At some time or another over the course of working within teams (with its diversity of good and not so good members), most of us have felt that something was unfair. But how do we really know what's fair or unfair? The best way to analyze the principles of justice is to ask some basic questions: did a perceived injustice involve lying or taking advantage of others? Did it involve playing by the rules or was it more about playing favorites? It can be difficult to stay objective when our emotions are concerned. The key is not to blame others for our own mistakes or deficiencies. We all know that life isn't fair. Stuff hits the fan, spreading its toxins over everything and everybody. What's at the root of unfairness? Perhaps it has to do with our expectations. Have we set our sights too high for team members, who like us are struggling to shift through ideals of fairness? Is the workplace really unfair? If the boss seems to favor one employee over the rest of the team, we might decide that the boss likes that person best and everyone else then feels second rate. When we acknowledge our expectations, we're better prepared to be more realistic and avoid disappointments.

Cape Town's R14 billion in new developments – completed, under construction and in the pipeline"

The Cape Town Central City Improvement District (CCID) has published it latest State of Cape Town Central City report, highlighting R14 billion worth of investment into new and future developments in the Mother City. The report, covering 2019, noted the challenges presented in that year, including the aftermath of the 2018 drought and subsequent water crisis, ongoing load-shedding and a tough economic climate.

While the impact of the 2020 coronavirus pandemic falls beyond the ambit of the SCCR report, it acknowledged the global devastation the virus has caused, noting that it "has damaged the Central City's economy".

"But the economic performance of what is arguably South Africa's most successful Central Business District **This is broken down into:**

means the Central City is well-placed to navigate a path to recovery," it said.

The SCCR report shows that, according to the City of Cape Town's 2018/2019 property evaluation, the value of Central City property stands at R44.124 billion, and that the total value of property investments in the Central City – recently completed, under construction, proposed or planned – is R13.83 billion.

The Foreshore precinct has emerged as a key property investment node which is due, in part, to the expansion in 2018 of the Cape Town International Convention Centre (CTICC), which achieved a turnover of R277 million in 2018/2019.

- ✓ R1 045 million A conservative estimate of the value of property completed in the Central City during
 2019 but which still has to be officially assessed by the City of Cape Town (7 projects);
- ✓ R3 730 million The value of property, conservatively estimated, that is under construction (14 projects);

 (11 projects); and
- ✓ R3 860 million The value of property, conservatively estimated, that is currently proposed and is
 expected to begin construction within the next two years (6 projects).



ESKOM to resume work on 123km powerline in KwaZulu-Natal

Construction of powerline to create 190 job opportunities across the five towns impacted by the project, BY **Scott Birch**, **21 October 2020**.



Eskom, the South African electricity public utility, is set to resume work on the construction of the final leg of the approximately 123-kilometre long transmission power line running through the uMgungundlovu and uThukela district municipalities in KwaZulu-Natal province. In a statement, the company says that the towns impacted are Pietermaritzburg, Estcourt, Howick, Richmond and Mooi-River. The final construction of the 47-kilometre leg of this power line will start from the existing Venus substation in Estcourt and end at the existing Ariadne substation in Pietermaritzburg. Eskom adds that it has been engaging with governmental, environmental and all relevant structures in the area, laying the groundwork for the construction to begin.

"It is important to note that this project will enable Eskom to fulfil its mandate of electricity provision to users in the area, as well as the entire province of KwaZulu-Natal," says Bob Naraghi, the grid manager at Eskom Transmission. "Since 2005, Eskom has been expanding its infrastructure through additional power stations and power lines, as well as strengthening and upgrading existing electricity infrastructure. This in turn will ensure that electricity users experience reliable power supply and that we meet the country's electricity demands. "As a responsible corporate citizen, the utility aims to make a positive and lasting difference to the lives of all South Africans, especially within KwaZulu-Natal," Naraghi states.

Highlighting the impact of COVID-19, Eksom says the project could not come at a better time. The utility provider says that the power line will contribute to bringing about economic change within the communities of the five affected local municipalities. The project has created 190 job opportunities, ranging from professional, skilled, semi-skilled and the unskilled workforce, benefitting communities within the municipalities impacted by the construction. It states that 70 percent of the employed workforce has come from the local communities within the relevant towns, with the entire team

completing induction at the beginning of October 2020. "On completion, the project will not only contribute to improved stability of the transmission network but will also create a more flexible network that will enhance electricity reliability. More importantly, this line will also contribute to the economic growth of the province," says Naraghi.

Eskom has also shared its Transmission Development Plan (TDP) for the period of 2021 to 2030 with various stakeholders during an online public forum. This process is part of Eskom's Transmission licence requirements issued by the National Energy

Regulator of South Africa (NERSA), which calls for Eskom to publish a TDP annually. Eskom in Gautena has injected R41 million on an 88kV power line upgrade to strengthen the electricity network infrastructure in the northern areas of Johannesburg. Sylvester Barei, Asset Creation Senior Manager in Gauteng, said: "This double circuit twin turn 88kV line which is capable of delivering over 200 MVA is one of our flagship projects aimed at realising economic activities and improving the quality of life in Gauteng."



New plan to privatise train routes in South Africa

18 October 2020

President Cyril Ramaphosa has proposed the privatisation of some of South Africa's key train routes in a bid to improve transport access to millions of South Africans.

The <u>City Press</u> reports that the proposal forms part of the president's new economic recovery plan and will primarily focus on routes in Gauteng and the Western Cape.

The route between Mabopane and Tshwane in Gauteng and the central Cape Town rail route in the Western Cape are reported to be high on the priority list.

"Access for third-parties on the railway network is exactly what we have been requesting for years," Mesela Nhlapo, chief executive of the South African Road Rail Association told the paper.



Nhlapo said that routes were seldom privatised in South Africa and that the standard way of privatising routes was through a public-private partnership where government is responsible for safety and maintenance of the lines.

"If that's the plan, it could unlock enormous opportunities. It could lead to fixed property becoming valuable retail spaces," she said.

Gautrain expansion

Gauteng's Gautrain route is also set to expand within the coming decade, says Gautrain Management Agency chief executive, William Dachs.

Dubbed 'Gautrain 2', the expansion project that would see an additional 149km of railway line and 19 new stations added to the existing network, and create up to 175,000 direct jobs in the construction phase, and 68,000 new jobs in the operational phase.

However, the project is only likely to commence in 2024. The first phase would see the network expanding by 32km, between Marlboro and Little Falls in Roodepoort, and consist of three new stations.

Dachs said in a webinar hosted by <u>CNBC Africa</u> on 21 September: "I don't think anyone has ever been to a city with a poor public transport network that was a competitive city and I'm afraid, and I think everyone in the province is afraid, that if we don't keep our planning for extending rail, and investing in rail, our cities are going to lose their competitive edge.

"And that's fatal in this world as we have it now," he said. "We've got to be getting a move on now, because we've got such a long lead time before anything actually happens in these massive infrastructure projects."






Here are SA's new, fast-tracked infrastructure projects worth R340 billion, Business Insider SA, Jul 27, 2020.

Government has gazetted details of 51 infrastructure projects that have been declared strategically important, and will be fast-tracked to secure the necessary approvals (including municipal rezoning and water rights) within 56 days.

During a briefing on Monday, Dr Kgosientsho Ramokgopa, head of the Infrastructure Investment Office in the Presidency, said that work on the projects should start within the next three months, or at the very least tenders should have been issued in this time. The projects are being fast-tracked to bolster job creation and the economy following the havoc wreaked by the coronavirus crisis.

Of the R340 billion needed to develop the projects, the necessary sovereign guarantees and approvals for increased borrowing have been secured, and funding has been agreed with private-sector banks and development organisations.

"Many of the projects – particularly in housing – will be financed by privatesector partners".

Here are the projects which will be fast-tracked:

Of the 51 projects, Gauteng will see the big allocation of new developments:

Water & Sanitation

Some R106 billion has been committed to water projects in all nine provinces, and 25,000 jobs are expected to be created.

- The Vaal River System including Phase 2 of the Lesotho Highlands Water Project: Gauteng
- Phase 2A of the Mokolo Crocodile River (West) Augmentation Project: Limpopo



Some 160km of pipeline, and pump stations to move water down it, will be built from the Mokolo dam in the mountains south of Lephalale. This will ensure more water to the local municipality – and secure water for the Medupi and Matimba power stations. It will also supply water to surrounding mines.

- Phase 2A of the Mokolo Crocodile River (West) Augmentation Project: Limpopo
- uMkhomazi Water Project: KwaZulu-Natal
- Olifants River Water Resource Development Project Phase 2: Limpopo
- Vaal-Gamagara: Northern Cape
- Mzimvubu Water Project: Eastern Cape
- Rehabilitation of the Vaalharts-Taung Irrigation Scheme: Northern Cape & North West
- Groot Letaba River Water Development Project Nwamitwa Dam: Limpopo
- Berg River Voëlvlei Augmentation Scheme: Western Cape
- Rustfontein Water Treatment Works: Free State
- Orange-Riet Canal Increase of Bulk Raw Water Supply: Free State
- The project will increase bulk raw-water supply to Letsemang, and help to support agricultural and renewable energy projects.

Energy

Allocations worth R58 billion will be fast tracked, and 6,000 jobs will be created.

- Emergency/Risk Mitigation Power Purchase Procurement Program (after installation, these sustainable energy producers should deliver 2000MW in power)
- Small IPP Power Purchase Procurement Program (100MW)
- Embedded Generation Investment Program (EGIP)-4 00MW



Transport

Projects worth R47 billion have been approved, to create 50,000 jobs

- N1 Windburg Interchange to Windburg Station: Free State
- N1 Musina Ring Road: Limpopo
- N1 Polokwane Eastern Ring Rd Phase 2: Limpopo
- N1 Ventersburg to Kroonstad: Free State
- N2 Mtunzini Toll Plaza to Empangeni T-Junction: KwaZulu-Natal
- N3 Cato Ridge to Dardanelles: KwaZulu-Natal
- N3 Dardenelles to Lynnfield Park: KwaZulu-Natal
- N3 Paradise Valley to Mariannhill Toll Plaza: KwaZulu-Natal

The upgrade of this section of the N3 highway will allow the road to accommodate the increase in traffic volumes expected over the next 30 years.

- N2 EB Cloete Interchange: KwaZulu-Natal
- Small Harbours Development: National
- N3 New alignment via De Beers Pass: Free State
- Boegoebaai Port and Rail Infrastructure Project: Northern Cape

Satellite Hub

Some *R4 billion* will be used to develop satellite infrastructure, including "earth observation satellites" and satellite bases. "Domestic access to this type of infrastructure will reduce South Africa's reliance on other countries for the type of information that these satellites can make available and is expected to reduce the timeframes for collecting necessary data," government said previously. It is estimated that the investment will generate R1.38 billion in GDP in the first year. This should create 700 jobs.

Agricultural and Agro-processing

Some R7 billion will be invested, which should create 4,000 jobs.

Marine Tilapia Industry: Eastern Cape

One project that was previously touted is a farm that will breed tilapia fish in the rural Mbashe municipality. The project could inject close to R600 million into the country's economy every year, government said recently.



Natural D ehydrated Foods: Mpumalanga

Affordable housing

Some R139 billion will be invested in these projects, with an estimated 190,000 jobs that will be created.

2020/21 Message to our SARWA members...


