## Legislative update ....

**T**he following right of way related pieces of legislation were in differing stages of finalization at the time of writing. We will endeavor to notify our members as and when updates are received.

*May this holiday season sparkle and shine for all SARWA members and their families.*

### The Communal Property Association Amendment Bill

**Objects:** To provide clarity on the objectives of CPA's, in order to protect the rights of beneficiaries, extend the application of the Act to certain labour tenants who acquired land, establishment of the CPA Office and appointment of a Register of CPA's. Public consultative processes underway.

**Objects:** To bring the provisions of the Act in line with the Constitution, especially as regards the principle of "just and equitable" compensation, amongst other things. The Act was not signed into law by the President amid concerns over lack of public participation.

### Restitution of Land Rights Amendment Act

**Objects:** To re-open window for restitution claims, to allow people to put in claims until 2018, including new claims for land dispossessed prior to 1913. Parliament passed the Act, however the Cons Court ruled it invalid on the grounds of lack of public participation. Con Court also ruled that no new claims may be processed until claims submitted in 1998 are finalized.

### Protection of Critical Infrastructure Bill

**Objects:** to provide for the repeal of the National Key Points Act, to provide for the identification of infrastructure as critical infrastructure and for measures to be put in place for the protection and safeguarding of critical infrastructure. Period for public comments closed 17 Nov 2017.

## Education and Accreditation for Rights of Way

SARWA as South Africa's land and rights learning institution offers national and internationally accredited qualifications and have world-class resources that inspire learners to create meaningful futures.

SARWA as a Chapter of the International Rights of Way Association (IRWA) offers learners the opportunity to take courses and achieve international accreditation in the rights of way profession.

At this time the Rights of Way accreditation is an International Accreditation through the IRWA. SARWA is working with the South African Qualification Authority (SAQA) to eventually have a South African Accreditation for Rights of Way. The goal is to have a SAQA accreditation on level seven which is equal to a Degree.

There are three international accreditations starting with the RWA (Right of Way Agent). The requirements are set out below.

## International Accreditation of Land & Rights Practitioners

### Right of Way Agent (RWA) Level 1 accreditation

Requirements: **64 Credit Units**

- 1 year ROW experience
- Degree or Diploma or 128 additional Credit Units of IRWA approved coursework
- Course 103 Ethics and the Right of Way Profession - **8 Credit Units** – Available in South Africa
- Course 200 Principles of Real Estate Negotiation - **16 Credit Units** – Available online
- Course 100 Principles of Land Acquisition - **32 Credit Units** – Available in South Africa
- Course 213 Conflict Management - **8 Credit Units** – Available in South Africa



## Right of Way Professional (RWA) Level 2 accreditation
