This new Bill covers:


- The establishment and maintenance of a register of public and private agricultural land holdings;
- The declaration of present ownership and acquisition of private agricultural land;
- The submission of information on public agricultural land;
- The prohibition on the acquisition of agricultural land by a foreign person;
- The regulation of lease by foreign persons;
- The determination of ceilings in respect of agricultural land and to provide for redistribution thereof.
